# Item 1. Economic and operational section

# 1.1 Publication of UNI Board Meeting Minutes

# 1.2 Update of the TBU Wage Regulations in Zlín

An amendment to the UTB Wage Regulations is currently being prepared. It is expected to include an increase in the tariff components of wages and a systematization of administrative and technical staff positions. The proposal is expected to be presented by the university management by May 31, 2025, with the amendment likely to come into effect on either September 1, 2025, or October 1, 2025...

## 1.3 UTB Budget Breakdown for 2025

The UNI budget is expected to increase by 15% year-on-year compared to the available funds for 2024. Prof. Sedlařík pointed out that purchases from the CirkAréna project will not be administered by the Rectorate, and therefore attention should be paid to avoid an increase in contributions.

# 1.4 Representation of UNI/CPS in the Academic Senate of TBU in Zlín

At the Academic Senate meeting held on April 8, 2025, Dr. Pavel Urbánek was elected to the Legislative Committee.

The next meeting of the Senate is scheduled for May 6. 2025. A meeting was held with the Rector regarding the possibility of amending the Rules of Procedure of the included Committee. Senate that UNI would be in the Economic The Economic Committee discussed the UTB Budget Breakdown for 2025.

#### 1.5 Review of Investments at UNI/CPS

Prof. Sedlačík presented a list of investments made at UNI/CPS over the past five years, including the sources of funding and the research areas for which these investments were primarily intended. This list was provided to the heads of UNI research centers and CPS research areas. Prof. Sedlařík emphasized the need to take into account project-related subsidies (for example, the TSI instrument was 70% funded by the Zlín Region). A discussion followed regarding investment requirements, co-financing, and the focus of investments, which—apart from asset renewal—should primarily target areas related to environmental issues and aerospace.



The Board agreed on the importance of timely communication of strategic projects and investments. It was proposed to organize dedicated meetings involving the center directors, research area coordinators, and development project leaders. Minutes will be taken from these meetings.

After discussions with the internal auditor, it was agreed that colleagues from other faculties would be involved in the evaluation committee to prevent potential conflicts of interest. Technical specifications will remain fully under the responsibility of UNI/CPS.

#### 1.6 Review of Building Conditions

- In building U11, access readers for authorized entry were replaced. Replacement in building U17 is expected within two weeks.
- Due to the walking distance to the U4 canteen, placing a vending machine in building U17 is being considered. It would dispense pre-packaged meals from the canteen, which would continue to be ordered via the WebKredit app. Meals would be reserved specifically for the ordering employee and would not be available to others. The machine has a capacity of 120 meals and could also serve students who have limited access to lunch during scheduled classes, including part-time students attending on Saturdays.
- UNI/CPS will newly be able to use one office space in building U6 (estimated 2–3 workstations).

#### **1.7 OP TAK**

Within the evaluation process of the OP TAK project "University Technology Center for Practice," Activity B – the purchase of investment instruments and establishment of laboratories (total funding CZK 34.95 million, with 50% co-financing) will be supported.

Activity A – provision of R&D services for companies – was not recommended for funding. The application will be revised and resubmitted if a relevant call is announced.

## 1.8 OP JAK - Research Environment

The project proposal for OP JAK "Research Environment" titled "Supporting the Development of a Diversified Excellent Research Environment at TBU in Zlín" has been submitted to the managing authority. UNI/CPS plans to participate in all 5 key activities planned by TBU. Although the probability of success is low (86 applications submitted with a total budget of CZK 3.6 billion), this ensures readiness for future calls.

# 1.9 OP JAK – Returns

A call has been announced under OP JAK "Returns," aimed at ensuring that career interruptions due to maternity/parental leave, long-term illness, or extended care for a child or close person do not result in termination or significant delays in the professional careers of researchers with high potential. UNI/CPS will submit a separate project proposal under UTB for this call, as it represents an excellent opportunity for human resources

development.

Dr. Mrlík has prepared a preliminary project draft and supporting materials, which will be discussed with the directors of UNI and CPS.

#### 1.10 ERDF kvalita – Modernization of Infrastructure and Better Academic Tools (MILAN)

The project was approved to start on January 1, 2025, with the UNI/CPS budget (CZK 6,269,116.44) not being reduced by the provider. The planned procurement period is from March to August 2025. The following six devices are planned to be purchased:

- a) An instrument for measuring specific surface area, pore size distribution analysis, and gas/vapor adsorption studies
- b) A device for measuring absorbance, fluorescence, and luminescence using monochromator-based microplate readers for determining viable cell concentrations and distinguishing live, dead, or non-



metabolizing cells

c) A reactor and cell setup for photocatalysis - classroom for multiplatform application development

- d) A lock-in amplifier for analyzing highly noisy signals and noise analysis
- e) A cutting mill
- f) Cryogenic mill

# 1.11 Cirkular Economy R&D Centre

As of April 1, 2025, staff appointments for the CirkArena project have begun. This is a research and development center focused on the circular economy, bringing together innovation teams and capacities with the ambition to integrate its facilities in Třinec into the system of national reference laboratories. The main areas of focus include construction waste recycling, waste streams specific to the Moravian-Silesian Region (e.g., vehicle dismantling – involving the research area Rubber Technology), and biowaste (TBU will be involved in two of three planned activities, through the Environmental Technologies and Nanomaterials and Advanced Technologies research areas). Prof. Sedlařík presented the project through a presentation, followed by a discussion of the project's benefits and commitments for UNI.

To finance the project's sustainability, UNI plans to gradually build a dedicated fund.

As part of sustainability efforts, an amount of CZK 80,000 has been allocated by the Rectorate for ESG-related measures.

#### **Item 2. Educational Section**

# 2.1 Amendment to the Higher Education Act

An amendment to the Higher Education Act has been approved, under which, from September 1, 2025, PhD students in full-time study programs at TBU will receive increased stipends so that their total countable income reaches at least 1.2 times the minimum wage. In this context, an interpretation by the Ministry of Education, Youth and Sports (MEYS) is expected, clarifying whether stipends can also be paid from DK RVO or SVV sources.

On April 15, 2025, a lecture was held by JUDr. Veronika Smutná, Ph.D., focusing on this amendment and its implications for doctoral studies.

In connection with the above, an internal regulation on the rules for PhD admissions and regular evaluations will be developed in cooperation with doctoral program guarantors. Discussions are currently underway on the basic concept for restructuring doctoral studies. The aim is to create support tools for students while also defining the conditions under which TUB may terminate a student's study.



At the vice-deans' meeting, the issue of tuition fees for foreign students was discussed. Individual faculties are expected to submit their position on this matter by the end of April 2025. UNI plans to set the tuition fees for foreign students equivalent to the financial contribution TBU receives for Czech students.

#### 2.2 New Vocational Secondary School Program: Shoemaker and Plastics Technician

In 2025, in cooperation with FRC and ČOKA, a new secondary school study program with a high school diploma titled Shoemaker and Plastics Technician will be launched at the Secondary Industrial School of Polytechnics – Vocational Training Center in Zlín. A regional information campaign is currently underway, and 30 applications have been submitted so far.

## 5.8 Cooperation with Scientific Institutions in China

The Ministry of Education (MEYS) does not explicitly forbid cooperation with scientific institutions in China. However, it is not recommended, and it is important to review the list created by MEYS, which outlines institutions that have significant collaborations with the Chinese government. Cooperation with these institutions is discouraged. Institutions that do not follow this recommendation may face sanctions in terms of national and international grant applications. Collaboration with selected Chinese institutions may lead to the exclusion of submitted projects from competitions.
